~~NOTICE IS HEREBY GIVEN:~~ That the undersigned, STAUFFER CHEMICAL COMPANY, in compliance with the requirements of the Revised Statutes of the United States and the local laws customs and regulations, has this day located and claims the following described placer mining grounds: Beginning at this monument of rock, where this notice is posted, which monument bears North 16° 25' West 260 feet from the Southeast corner of this claim; from said Southeast corner the boundaries of the claim run West 660 feet to the Southwest corner; thence North 1320 feet to the Northwest corner; thence East 660 feet to the Northeast corner; thence South 1320 feet to said Southeast corner; together with all water and timber appurtenant, allowed by law.

This claim, consisting of 20 acres, shall be known as APRIL #23 Mining Claim. 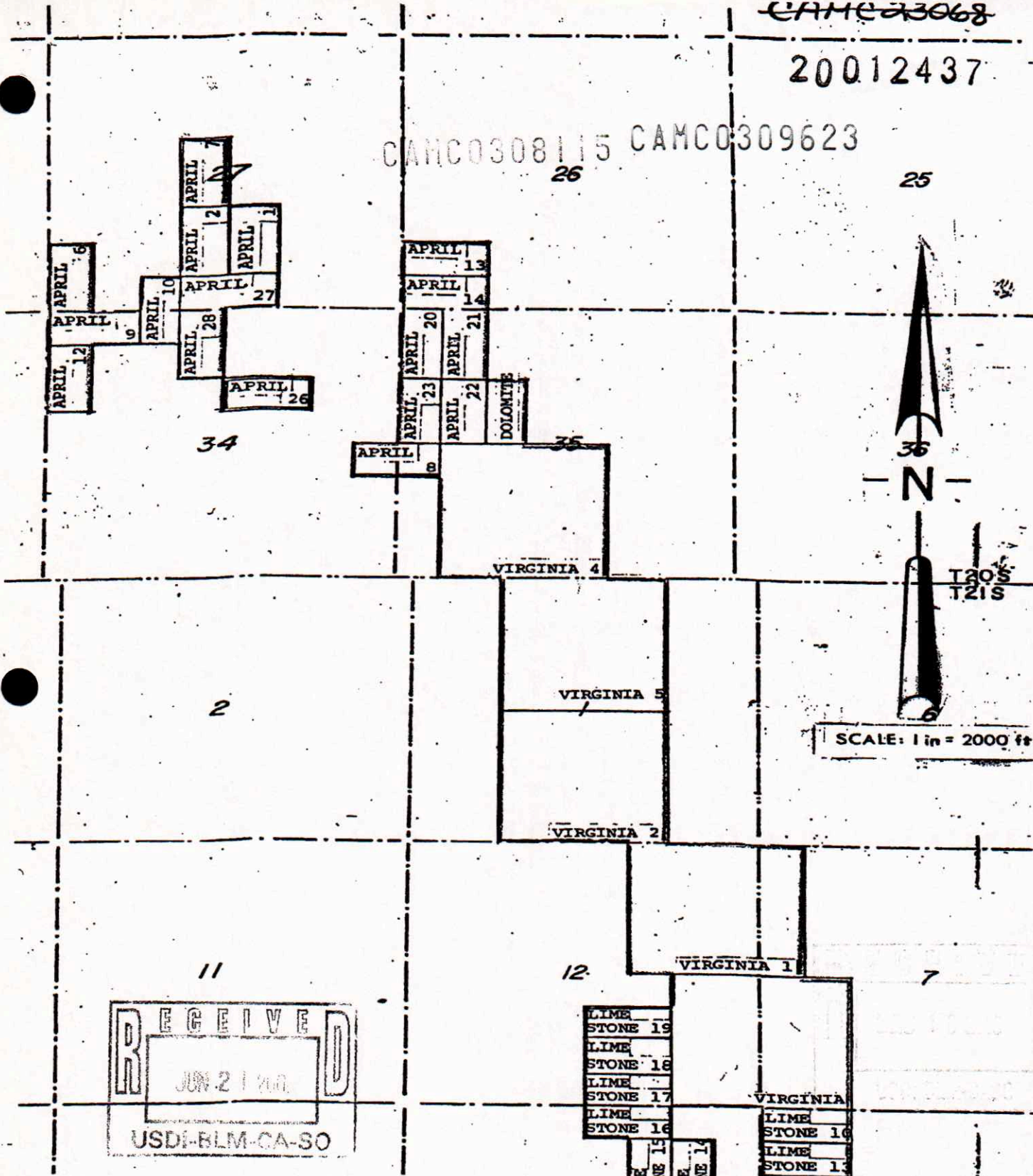
