SUBJECT: Possible Approval of Letter Opposing SB 594 and Amending the Legislative Platform

DEPARTMENTAL RECOMMENDATION: - Request Board consideration of (a) a letter opposing SB 594 (Hill) and (b) amending the Legislative Platform to add under the General Government Section Item No. 23. **Oppose** Legislation that eliminates, diminishes, limits or interferes with the nonprofit organizations that the County has membership in, i.e., CSAC, RCRC, State Sheriff's Association, Chief Probation Officers Association, State Welfare Directors Association, etc., in actively participating in the legislative and ballot measure processes.

SUMMARY DISCUSSION: - Mr. Matt Gate, Executive Director of CSAC asked the County to oppose SB 594 (Hill). This legislation is targeting nonprofit organizations like CSAC, who receive public funds from participating in the ballot measure process. Recently these organizations have been successful in protecting local governments from raids on property tax, unfunded state mandates, secured funding for schools and public safety, and promoted pension reform all to the ire of a few special interest groups. This legislation is bad for California counties and will negatively impact Inyo County's ability to participate in the State legislative process. The County's Legislative Platform does not cover this type of legislation and it is staff's recommendation that an item be added to the General Government Section of the Platform to provide for the County's position should this arise in the future.

ALTERNATIVES: - Your Board could choose to not add this item to the Legislative Platform. This alternative is not recommended in that it is important for the Board of Supervisors to be able to respond to legislative requests quickly and this addition will provide that opportunity in the future.
