The Inyo County Public Works Department proposes the Walker Creek Road Bridge Replacement Project, which would involve the replacement of County Bridge 48C0039 with a new bridge and would close the existing bridge to public vehicular traffic. The proposed project would also include the realignment of Walker Creek Road as it approaches the bridge in either direction. The existing bridge was classified as functionally obsolete according to the National Bridge Inspection Standards. The new bridge is structurally sound, meets modern structural and safety codes, and provides adequate vehicle access between U.S. Highway 395 and destinations west of the LA Aqueduct.
