

PROGRAM PHILOSOPHY

Individuals in need of addictions treatment often are experiencing stressors in the related life domains of work, family, school, spirituality, leisure, income. We make every effort to treat individuals holistically. Clients are encouraged to participate fully in all aspects of treatment, addressing all life domains in their efforts to sustain a productive and substance free lifestyle. This participation is necessary in the creation of a safe and confidential treatment environment. Services are provided in coordination and cooperation with services funded by Mental Health, CalWORKS, Child Protective Services, Probation, and/or other services and agencies as needed.

The Inyo County program approach to recovery is based on the fundamental ideas that alcohol and other drug addiction is a progressive disease. Individuals suffering from the disease of alcohol and/or drug addiction have a right to recovery. Family, friends and the community are a source of help for the alcoholic/addict.

Alcohol and drug addictions are symptoms of an active disease.

The immediate goal of our program is to achieve recovery for the individual and successfully address the negative emotional effects caused within the family. Our overall goal for the individual is the development of appropriate recovery skills and supports necessary to lead an alcohol and/or drug free, productive life.

GRIEVANCES

Persons who are not happy with their Alcohol and Other Drug Services may talk or write to us. We will work to solve the problem. You will continue to get the same services while your problems are being solved. The Alcohol and Other Drug Services has a process to ensure that a client is not subject to any penalty for filing a grievance. Inyo County Alcohol and Other Drug Services have a grievance process. (see AODS Problem Resolution Guide).

COMPLAINTS

In accordance with Title 9, Section 10544 of the California Code of Regulations, any individual may request an inspection of an alcoholism or drug abuse recovery or treatment facility (see AODS Problem Resolution Guide).

PARTICIPANT RIGHTS

In accordance with Title 9, Chapter 4, Section 10569 of the California Code of Regulations, each person receiving services from a residential alcoholism or drug abuse recovery or treatment facility shall have rights which include, but are not limited to the following:

- The right to confidentiality as provided for in Title 42, Code of Federal Regulations, Part 2.
- To be accorded dignity in contact with staff, volunteers, board members and other persons.
- To be accorded safe, healthful and comfortable accommodations to meet his/her needs.
- To be free from verbal, emotional, physical abuse, and/or inappropriate sexual behavior.
- To be informed by the program of the procedures to file a grievance.
- To be free from discrimination based on ethnic group identification, religion, age, sex, color, or disability.
- To be accorded access to his/her file.



MISSION STATEMENT

The Inyo County Health and Human Services staff is committed to assisting persons in need by providing a range of integrated services, which are focused on improving the clients' ability to live independently and productively in the community. - **Relapse Prevention and Intervention** weekly adult education group
- Adult intensive outpatient with groups and individualized case management from 4-9 hours a week
- **Peri-natal** program is for women who are either pregnant and/or parenting, with children birth to 17 and are dealing with substance abuse issues.(45CFR Pregnant women are given preference in admission).
- **Adolescent** substance education and prevention groups.
