*FAC section 15204(a) requires each licensed Branch 2 and Branch 3 structural pest control operator qualifying manager, and SPCB registered company to register with the commissioner prior to operating a structural pest control business in the county. The registration shall cover a calendar year.

* B&P Code section 8610(c): Each registered company shall designate an individual or individuals who hold an operator's license to act as its qualifying manager or managers. The qualifying manager or managers must be licensed in each branch of pest control in which the company engages in business. The designated qualifying manager or managers shall supervise the daily business of the company and shall be available to supervise and assist all employees of the company, in accordance with regulations which the board may establish.

* B&P Code section 8611: Each branch office shall have a branch supervisor designated by the registered company to supervise and assist the company's employees who are located at that branch. The branch supervisor shall be an individual who is licensed by the board as an operator or a field representative and his or her license shall be prominently displayed in the branch office.

*B&P Code section 8505.17(c) requires registered structural pest control companies to submit to the county agricultural commissioner a monthly report of all pesticides used in that county. The report shall be submitted to the commissioner by the 10th day of the month following the month of application. When no pest control is performed during a month, the registered company shall submit a use report stating this fact to the commissioner.
