**Background Information:** This is a joint Town of Mammoth Lakes Town Council and Inyo County Board of Supervisors workshop to discuss regional airport development issues, including existing and future facilities at Mammoth Yosemite Airport and Bishop Airport. The Town Council and the Board of Supervisors have each previously executed an Outline Statement of Intent in Support of Reliable and Expanded Air Service. On August 1, 2018, Town Council received a comprehensive update of issues related to Mammoth Yosemite Airport and provided direction to staff. For this workshop, Town staff has met with representatives of Inyo County, Mammoth Lakes Tourism and Mammoth Resorts. The planned presentation includes:

- Brief overview of Mammoth Yosemite Airport (MMH), existing facilities and future planning
- Brief overview of Bishop Airport (BIH), existing facilities and future planning
- Mammoth Lakes Tourism update on air service
- Mammoth Resorts comments on their support to transition commercial service to BIH
- Town Council and Board of Supervisors discussion of above items and overall attitude/support for commercial service initiation at BIH.
