Local Information, Action, & Recommendations

CRITICAL REMINDER - Failure to comply with Health Officer Orders places individuals and our community at increased risk of infection. Violation of Health Officer Orders may also result in a misdemeanor punishable by imprisonment, fine, or both (Health and Safety Code §120295). Additional actions may be taken by the Health Officer, including civil detention or requiring one to stay at a health facility or other location, to protect the public's health if an individual who is subject to a Health Order violates or fails to comply with Health Officer orders. The best enforcement tool we have is social pressure, so if you see

- Executive Order Price Gouging: Governor Gavin Newsom signed an executive order on April 3rd expanding consumer protection against price gouging as California continues to respond to the COVID-19 pandemic. The order generally prohibits sellers of any kind from increasing prices on food, consumer goods, medical or emergency supplies, and certain other items by more than 10 percent. The order also gives additional tools to the California Department of Justice and Attorney General's Office, among others, to take action against price gougers. - Executive Order Expand Telehealth Services: Governor Gavin Newsom signed an executive order on April 3rd to expand protections to medical providers as they amplify the use of video chats and similar applications to provide routine and non-emergency medical appointments in an effort to minimize patient exposure to COVID-19. The order relaxes certain state privacy and security laws for medical providers, so they can provide telehealth services without the risk of being penalized. For more information visit:
