Local Information, Action, & Recommendations

- Inyo County Special Board of Supervisors Meeting Accelerated Stage 2: The Inyo County Board of
 Supervisors approved a letter of support for the submission of Inyo County's attestation to CDPH
 notifying them that Inyo County meets the State of California's readiness criteria to move through the
 Second Stage of Reopening at its own pace. Inyo County residents should note that if two confirmed
 cases occur prior to approval by CDPH the variance may not being approved.
- CRITICAL REMINDER Failure to comply with Health Officer Orders places individuals and our community at increased risk of infection. Violation of Health Officer Orders may also result in a misdemeanor punishable by imprisonment, fine, or both (Health and Safety Code §120295).
