Olancha Lake LLC is requesting a merger of six parcels. This request requires a Tentative Parcel Map. This parcel merger requires a Zone Reclassification and General Plan Amendment to create the correct land use designations for the proposed commercial RV camping business. The zoning designation would change to Commercial Recreation with 60-acre minimum (C5-60) and the General Plan designation to Resort Recreational (REC). The REC designation is intended for a mix of tourism-oriented commercial and residential uses. The proposed parcels are located in Olancha, one-eighth of a mile east of Highway 395, abutting SR 190. The properties are currently zoned Rural Residential with a 5-acre minimum with a General Plan designation of Residential Estate (RE). The six parcels to be merged include the following Assessor Parcel Numbers (APNs): 033-500-03, 033-500-04, 033-500-14, 033-500-15, 033-500-16, 033-500-17

If you challenge any finding, determination or decision made regarding this project in court, you may be limited to raising only the issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered prior to the hearing.
