Local Numbers Update

Inyo County Cases:

• 106 confirmed COVID-19 cases | 3 deaths | 54 resolved

Inyo County Testing:

- Total Tests Administered*: 3,442
- Tests Positive: 106
- Tests Negative: 2,727
- Tests Pending**: 578

*Data sources include testing totals from NIHD, SIHD, Toiyabe and Verily testing site, as they become available. Positives tests for those who are not full time residents in Inyo County are not included in the Positive Case count. Total, pending, and negative test numbers include individuals tested more than once.

**Cases with pending results are monitored by medical staff ordering test; Inyo County Public Health monitors pending results identified as high probability individuals.

Local Information, Action, & Recommendations

- Inyo County Positive Spike: Inyo County has recently experienced a significant spike in COVID-19 lab confirmed positive results, with 48 new positive cases, which includes 2 new deaths between August 1st and August 10th, many of whom are Bishop Care Center residents and employees. The outbreak was initially confined to the Bishop Care Center, however as individuals continue to gather and move throughout the community we anticipate the positivity rate to increase. The current outbreak highlights the extreme importance of limiting your contacts and avoiding gatherings of people outside of your household members. This is especially important if you have any contact with those most vulnerable to the disease, including the elderly and immune-compromised.
 California has temporarily stopped adding or removing counties from the County Monitoring List in response to a technical issue with the state's COVID-19 testing database, however Inyo County officials expect State agencies to be in contact with us in regards to the spike and to be potentially placed on the Monitoring List.
- **2020 Tri-County Fair Cancelled:** The 2020 Tri-County Fair has been cancelled due to the COVID-19 Pandemic. For more information visit: <u>https://tricountyfair.com/</u>
- Youth Sports: On August 3rd the California Department of Public Health released guidance on youth sports. The guidance establishes a consistent set of rules that apply to all youth sports programs including school-based, club, and recreational programs. Outdoor and indoor sporting events, assemblies, and other activities that require close contact or that would promote congregating, such as tournaments and competitions, are not permitted at this time. Youth sports and physical education are permitted only when physical distancing of at least six feet and a stable cohort of participants, such as a class, can be maintained.
