- **COVID-19 Paid Sick Leave:** On September 9th Governor Gavin Newsom signed AB 1867, legislation that immediately extends critical paid sick days protections to California’s workforce. This legislation means that every California employee that has been exposed to or tests positive for COVID-19 will have access to paid sick days for the rest of the 2020 calendar year.
