The applicant (Desert Greens LLC) has applied for two conditional use permits, on two separate parcels, along Old Spanish Trail Highway, in Charleston View, California. The first CUP (2020-10) is to operate a cannabis distribution facility, located at 127 Old Spanish Trail Highway (048-391-07). The distribution facility includes a 120' x 40' building with a storage room, shipping and receiving area, multiple office rooms, a restroom, and a security room. Deliveries will enter/exit along Old Spanish Trail Highway. The property is zoned Highway Services & Tourist Commercial (C2). The second CUP (2020-11) is for cannabis cultivation on a property located at 206 E. Hall Ln (048-391-10). The cultivation will occur outdoors, using a shade cloth protectant, and the total area under cultivation will be less than 1 acre. The project includes a 50' x 50' warehouse structure with lockers/clean room, a security room, a general work room, a trim room, an office room, restrooms, commercial freezers, and harvesting equipment. This property is zoned Rural Residential (RR). The properties for both CUPs are each approximately 2.5-acres. The perimeters around both CUP sites will be lined with security fencing and gates.
