## PUBLIC HEARING NOTICE

NOTICE IS HEREBY GIVEN the Inyo County Planning Commission will conduct public hearings Wednesday, July 28, 2021, at 10:00 a.m. to consider the following applications:

**Conditional Use Permit #2021-02/Cook & Variance # 2021-02/Cook**

In order to minimize the spread of the COVID-19 virus, Governor Newsom has issued Executive Orders that temporarily suspend certain requirements of the Brown Act. Please be advised that the Planning Commission will be conducting its hearing exclusively via videoconference by which Planning Commission Members and staff will be participating. The applicant (Reginald Cook) intends to cultivate hemp outdoors in three areas of their property totaling approximately 11,410 square feet. The applicant will be planting directly into the soil, and each cultivation area has been previously disturbed and used as a vegetable garden or lawn. The applicant has also applied for a variance of 295 feet to cultivate hemp within the 300-foot setback requirements. The available growing area in this parcel is constrained by the shape of the parcel and the unique rock formations found on the property. This property is zoned OS-40, located in a remote area surrounded by state and federal land, and is not within 600-feet of a school, daycare, park or library; and therefore, is not prohibited by state or county exclusion areas.

If you challenge any finding, determination or decision made regarding this project in court, you may be limited to raising only the issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered prior to the hearing.
