## BOARD OF SUPERVISORS TO CONSIDER COUNTY AND PUBLIC RIGHT-OF-WAY ISSUES

The Inyo County Board of Supervisors will hear a presentation at its Tuesday, May 26 meeting about County and public right-of-way rights and responsibilities. The agenda item, being presented by Inyo County Public Works, will take place during the departmental portion of the meeting, which begins at 10 a.m.

Public Works' presentation will include a discussion of proposed rules on sidewalk and tree maintenance, repairs, removal, and installations.

"Like the Board, the Public Works Department understands that many people in the community have strong thoughts on these issues, and therefore we want to ensure that all interested parties are informed about this workshop and have the opportunity to provide public comment," said Public Works Director Mike Errante.

It's important to note that during these unprecedented times, the Inyo County Board of Supervisors is still holding regularly scheduled Board meetings through Zoom (a web-based meeting/video conferencing platform), and welcomes public participation and discussion. Written public comment, limited to 250 words or less, may be emailed to the Assistant Clerk of the Board at boardclerk@inyocounty.us</a>. Your written comments will be entered into the official record, but may or may not be read aloud at the meeting.
