

ORDINANCE NO. 1165

**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE
COUNTY OF INYO, STATE OF CALIFORNIA, REPLACING SECTION
1.12.020 OF CHAPTER 1.12 OF THE INYO COUNTY CODE, IN INYO
COUNTY, CALIFORNIA**

SECTION ONE. FINDINGS/PURPOSE.

The purpose of this Ordinance is to update Inyo County Code Section 1.12.020 to reflect the population for the County as established by the 2010 Federal Decennial Census. By taking this action, the Board of Supervisors makes Chapter 1.12 current, reflecting that there are not changes to the supervisorial districts in Inyo County resulting from the Census.

SECTION TWO. AUTHORITY.

This Ordinance is enacted pursuant to the authority given to this Board of Supervisors by Government Code Section 21500, which requires the Board of Supervisors to adjust boundaries of any and all of the supervisorial districts of the County so that the districts shall be as nearly equal in population as may be.

SECTION THREE. ORDINANCE 1047 REPEALED.

Inyo County Ordinance 1047 is repealed to the extent it created Section 1.12.020 of the Inyo County Code.

SECTION FOUR. INYO COUNTY CODE SECTION 1.12.020 REPEALED AND REPLACED.

Inyo County Code Section 1.12.020 is repealed and replaced with the following:

1.12.020 Supervisorial districts - Population.

As of the 2010 Federal Decennial Census of the unincorporated territory of Inyo County and the incorporated City of Bishop, the population of each district and percentage of each district to the population of Inyo County as a whole is as follows:

District	Population	Percentage
First District	3,778	20.4%
Second District	4,177	22.5%
Third District	4,037	21.8%
Fourth District	3,172	17.1%
Fifth District	3,382	18.2%

SECTION FIVE. EFFECTIVE DATE.

This Ordinance shall take effect and be in full force and effect thirty (30) days after its adoption. Before the expiration of fifteen (15) days from the adoption thereof, this Ordinance shall be published as required by Government Code Section 25124. The Clerk of the Board is hereby instructed and ordered to so publish this Ordinance together with the names of the Board members voting for or against the same.
