Letter of Support

The Board of Supervisors of the County of Inyo, State of California, met in regular session at the hour of 8:38 a.m., on June 21, 2022 in the Board of Supervisors Room, County Administrative Center, Independence, with the following Supervisors present per California Assembly Bill 361: Chairperson Dan Totheroh, presiding, Jeff Griffiths, Rick Pucci, Matt Kingsley, and Jennifer Roeser. Also present: County Administrator Leslie Chapman, Assistant Clerk of the Board Darcy Ellis, and County Counsel John-Carl Vallejo.

- Public Comment The Chairperson asked for public comment related to Closed Session items and no one requested to speak.
- Closed Session Chairperson Totheroh recessed open session at 8:32 a.m. to convene in closed session with all Board members in attendance, except Supervisor Kingsley, to discuss the following item(s): CONFERENCE WITH COUNTY'S LABOR NEGOTIATORS - Pursuant to Government Code §54957.6 - Regarding employee organizations: Deputy Sheriff's Association (DSA); Elected Officials Assistant Association (EOAA); Inyo County Correctional Officers Association (ICCOA); Inyo County Employees Association (ICEA); Inyo County Probation Peace Officers Association (ICPPOA); IHSS Workers; Law Enforcement Administrators' Association (LEAA). Unrepresented employees: all. - Chairperson Totheroh recessed closed session and reconvened the meeting in open session Open Session at 10:00 a.m. with all Board members present. (Supervisor Kingsley joined at this time via Zoom.)
- Supervisor Roeser led the Pledge of Allegiance. Pledge of Allegiance
- Report on Closed County Counsel Vallejo reported that no action was taken during closed session that is required to be reported. Session
- Public Comment Chairperson Totheroh asked if there was any public comment pending for items not calendared on the agenda and comment was made by Lauralyn Hundley.
- Supervisor Roeser introduced Brenda Ling, new Superintendent at Manzanar National Historic Introduction Site, to the Board.

CAO -Moved by Supervisor Roeser and seconded by Supervisor Griffiths to approve a letter of support for the Silver Peaks Apartment project and authorized the Chairperson to sign. Motion Silver Peaks carried unanimously. Apartment Project

CAO-Economic Moved by Supervisor Roeser and seconded by Supervisor Griffiths to approve Amendment No. 2 to the contract between The Ferguson Group, LLC and County of Inyo for provision of Development – Federal Advocacy Services, extending the term from July 1, 2018 to June 30, 2023 in an Ferguson Group amount not to exceed \$101,000, contingent upon the Board's approval of the Fiscal Year 2022-Contract Amendment 2023 Budget, and authorized the Chairperson to sign. Motion carried unanimously.

HHS- First 5 -Moved by Supervisor Roeser and seconded by Supervisor Griffiths to approve the contract extension between the County of Inyo and First 5 California of Sacramento, CA for the First 5 California provision of home visiting coordination funding in an amount not to exceed \$90,772.92 for the Contract Extension period of December 9, 2020 through June 30, 2023, contingent upon the Board's approval of future budgets, and authorized the HHS Director to sign. Motion carried unanimously.

Moved by Supervisor Roeser and seconded by Supervisor Griffiths to approve the Probation -Memorandum of Understanding between the County of Inyo and Inyo County Superior Court Invo County Superior for funding of Probation staff and expenditures related to the "expanded pretrial release Court program," for the term June 22, 2022 through June 30, 2023 and renewed annually, contingent MOU Approval upon the Board's approval of future budgets, and authorized the Chief Probation Officer to sign. Information Services - Re-establishing Broadband Consortium/ Reso # 2022-21

BOS-Fish Springs Workshop

At the request of County Administrative Officer Chapman, the Board moved this item from the Contest Agenda to Departmental so CAO Chapman could explain the need to re-establish a Broadband Consortium in order to apply for grant monies and that expediting this process is necessary due to the application due date of July 15. It was decided that the ESCOG Board would be the appropriate group to take on this task.

Moved by Supervisor Griffiths and seconded by Supervisor Roeser to approve and authorize the Chairperson to sign proposed Resolution No. 2022-21 and direct the Eastern Sierra Council of Governments to apply for broadband consortia funding allocated under the California Advanced Services Fund in order to re-establish the Invo-Mono Broadband Consortium. Motion carried unanimously.

Supervisor Roeser introduced a workshop with the Big Pine Paiute Tribe and California Department of Fish and Wildlife, regarding groundwater pumping and other operations at the Fish Springs Fish Hatchery – specifically, concerns about over-pumping and a desire to help restore the water table and vegetation through a reduction in pumping at the hatchery. She explained that historically Big Pine Paiute Tribe has not been given a seat at the table and in offering the County's support, hoped to elevate their voice.

In attendance in person and via Zoom were numerous representatives of local, state, and federal agencies who had been invited to participate in discussions, and hopefully help suggest pathways forward for remedying the groundwater situation.

Big Pine Paiute Tribe Environmental Director Sally Manning and Water Program Coordinator Noah Williams gave a presentation which communicated the historical perspective and Tribal members' current concerns with groundwater pumping at the hatchery. They presented ideas for reducing pumping, noting that the hatchery is supposed to be an LADWP mitigation project. Ms. Manning and Mr. Williams said that while a possible 12% reduction is a start, it is not nearly enough to restore the springs in the area.

CDFW Fish Springs Hatchery Manager Dan Tonseth gave a presentation which included pending projects and proposals for water conservation by CDFW. Senior Environmental Scientist Supervisor Matthew Norris spoke about the progress being made on multiple projects where CDFW is working with LADWP to keep equipment up to standards and implement needed upgrades to the aging equipment at the Fish Springs Hatchery location.

Board members posed questions to the Tribe, Water Department, and County Counsel about historic land ownership in the Fish Springs area, water levels needed to sustain fish rearing at the hatchery, and which agencies have what kind of authority to make what kind of changes.

Supervisor Roeser said the Tribe's proposed project would need financial support as well as the expertise of various entities. County Administrator Chapman listed some of the agencies involved – and participating in today's meeting – who can provide the kind of assistance needed. agencies involved and interested in helping to resolve this issue.

The Board heard expressions of excitement, hope, and support from:

- Terri Red Owl, Executive Director of the Owens Valley Indian Water Commission and member of the Inyo County Water Commission;
- Danny McClure, Lahontan Water Quality Control Board Water Resource Control Engineer;
- UCLA student Jory Lerback; and
- Paul Huette, Utility Operator/Community Development Department Chairman for the Big Pine Paiute Tribe and member of the Inyo County Water Commission.

LADWP Aqueduct Manager Adam Perez also addressed attendees. Additional comment was provided by Los Angeles resident Sylva Blackstone and Milo Vella, a Cornell University student interning with the Tribe.

- *Recess/Reconvene* The Chairperson recessed the meeting at 11:57 a.m. and reconvened the meeting in the Fish Springs Fish Hatchery parking lot at 1:20 p.m. with all members present except Supervisor Kingsley.
- BOS Fish SpringsSupervisor Roeser welcomed attendees to a field trip to a proposed project site near the Fish
Springs Fish Hatchery, which was led by Big Pine Paiute Tribe Environmental Director Sally
Manning.

Tribal elder Ross Stone spoke about the history of the area surrounding the hatchery and sang a prayer song with his wife. Charlotte Lange, Mono Lake Kutzadika'a Chairperson and Big Pine resident, also addressed the group, thanking the various parties for coming together to hear the Tribe.

Supervisor Pucci had to leave the field trip at 2 p.m.

Participants, including Chairperson Totheroh and Supervisors Roeser and Griffiths, then

carpooled to the proposed mitigation site: long-dry five-acre pond. Exploration and discussion ensued, with Ms. Miller offering the option to continue the tour to another possible mitigation site.

Adjournment Chairperson Totheroh adjourned the meeting at 2:31 p.m. to 8:30 a.m. Tuesday, June 28, 2022 in the County Administrative Center in Independence.
