

## **County of Inyo Board of Supervisors**

## <u>July 5, 2022</u>

The Board of Supervisors of the County of Inyo, State of California, met in regular session at the hour of 8:30 a.m., on July 5, 2022 in the Board of Supervisors Room, County Administrative Center, Independence, with the following Supervisors present per California Assembly Bill 361: Chairperson Dan Totheroh, presiding, Jeff Griffiths, Rick Pucci, Matt Kingsley, and Jennifer Roeser. Also present: County Administrator Leslie Chapman, Assistant County Administrator Sue Dishion, and County Counsel John-Carl Vallejo. Absent: Assistant Clerk of the Board Darcy Ellis.

Public Comment	The Chairperson asked for public comment related to Closed Session items and no one requested to speak.

Clerk of the Board – Bishop Fire District Appointments	Moved by Supervisor Pucci and seconded by Supervisor Kingsley to reappoint Ms. Suzanne Butler, Mr. Scott Marcellin, and Mr. Michael Holland to the Bishop Rural Fire Protection District Board of Commissioners. Motion carried unanimously.

CAO-Advertising County Resources – Langley Contract Amendment 1 Moved by Supervisor Pucci and seconded by Supervisor Kingsley to ratify and approve Amendment No. 1 to the agreement between the County of Inyo and Chris Langley for provision of Film Commissioner services, extending the term to September 30, 2022 at a total amount not to exceed \$12,700, and authorize the Chairperson to sign. Motion carried unanimously.

Supervisor Pucci reported that the Fourth of July festivities in the Bishop area were well done and well attended.

Supervisor Totheroh said he will be attending an Eastern Sierra Council of Governments meeting on Friday.

Supervisor Griffiths said there was a wonderful Fourth of July celebration in the Bishop City Park, adding that he attended a City of Bishop-Inyo County Liaison Committee meeting last week, and that he will be attending next week's supervisors meeting via Zoom.

County Counsel – Purchasing Policy Presentation
Deputy County Counsel Grace Chuchla gave the Board a presentation regarding proposed updates to the Inyo County Purchasing Policy. Auditor-Controller Amy Shepherd and CAO Chapman provided additional information. The Board was supportive of the changes and complimentary of staff's work. Staff was directed to start the approval process for those updates.
