a. Marilyn Mann: ESAAA Administrative Staffing Report

Marilyn Mann provided an update on the Advisory Council vacancies (3) currently recruiting for in Inyo and Mono County.

b. Morningstar Willis-Wagoner: ESAAA Services Report for PSA 16 for FY 2021-2022 and midyear for FY 2022-2023

Morningstar Willis-Wagoner provided an update on the continued increase in the number of congregate and delivered meals provided in both Inyo County and Mono County.

c. Paulette Erwin: Long-Term Care Ombudsman Report

Paulette Erwin reported on her work for Elder Abuse Awareness for the month of June. Sharing the placemat she designed & will be distributing to the Senior Centers and local Business's.

d. Mono County Updates

Krista Cooper gave brief update regarding Mono County Road closures and the in-home delivery of meals to seniors in the tri-valley area, because of the recent storms. Kathy Peterson gave an update on the program they're implementing to help create connection among older adults and people with disabilities with loved ones. They are excited about this program and hope to share what they learn from this program at a future ESAAA meeting.

8. <u>Public Hearing on the Annual Update of the Area Plan for PSA 16</u>

- a. Marilyn Mann provided the annual summary of the Area Plan Update. Stating that one of the items identified as a barrier for many eligible residents in both Inyo and Mono Counties is able to access medical and specialty medical and other critical social service resources.
- b. We as an agency are recommending maintaining the minimum percentages. This is more specific to the supportive service funding, which is called IIIB. They've historically been:

50% Access: Transportation/Assisted Transportation 5% In-Home Services 10% Legal assistance

The dollar amount for both Inyo and Mono counties has historically been about \$100,000 for supportive services. Over the last three years with the influx of funding coming in to support a wider range of support to our residents, teasing out what funding is going to be continuing beyond the pandemic has been a little challenging.

c. Paulette Erwin discussed the Ombudsman Long-Term Care. She explained how the data is collected is entered causing the baseline resolution on page 19, to look like the resolution percentage is low and the investment hasn't been as affective as it really is. When it should show how effective the Ombudsman is in resolving a complaint. She also shared a new interactive training that's been developed for the LTC facilities & Senior Centers.

Comments: One Council member indicated an interest in bringing the interactive training to Mono County. No other comments were made.
