#### ITEM 4. Commission Appointments

Excerpt from First 5 Inyo County Bylaws Article VI: Officers and Duties

- 1. The officers of the Commission shall be a Chairperson, elected annually to serve for a term of one year, a Vice-Chairperson and such officers as the Commission may designate. Pursuant to section 2.50.110 of the Inyo County Code, the commission shall make such rules and regulations as are necessary to conduct its business.
- 2. All officers shall be elected by a majority of the voting members of the Commission at a regular meeting or special meeting where a quorum is present. This person must be a member of the Commission duly appointed by the Board of Supervisors. All officers shall hold office until their successors are duly elected. Officers may be re-elected to the same office or elected to a different office without restriction on the number of terms.
- 3. The Chairperson shall preside over all business and meetings of the Commission. In the absence of the Chairperson, the Vice Chairperson shall conduct routine business matters and meetings.

ITEM 4. Director Report

Details: Director will report on programs and activities. Items underlined include additional documents following.

- **Staff Vacancies:** We are currently recruiting for a Home Visitor. Funding for this position comes from the allocation from the California Home Visiting Program (CHVP) Evidence Based Home Visiting (EBHV) Grant and the Substance Abuse Block Grant.
- 2023 Holiday Toy Shop: Staff hosted the annual Holiday Toy Drive and Toy Shop. Well over 1000 gifts and staffed animals were generously donated by HHS staff and community members. California Highway Patrol Office Michner facilitated a generous donation of over 200 gifts. Donations were collected in Bishop, at the Quilter Consolidated Offices Building and the Lone Pine County Offices Building. The Toy Shop provided gifts to 600 children throughout Inyo County. There were three locations, one in Bishop, Lone Pine, and Tecopa. Staff promoted the Holiday Toy Shop on Sierra Wave media Skippable News in December. https://youtu.be/lycO3Jras-A?si=Nk2dOV6gLcZ3Fled (25:23)
- Perinatal Taskforce: The January Perinatal taskforce meeting was held on January 11<sup>th</sup>. Mono County First 5 delivered a presentation about their Home Visting Program and how to refer families. During report outs from the taskforce, members shared that the Ridgecrest Labor and Delivery would be closing, and Northern Inyo Hospital will be the only Labor and Delivery location open from Lancaster to Carson City, NV. Inyo County WIC will be hosting a National Nutrition Month event on March 14<sup>th</sup> from 3:00 to 4:30PM at the Bishop City Park.
- Triple P Positive Parenting Program: January is Positive Parenting Awareness month. Staff promoted Positive Parenting Awareness Month on Sierra Wave Media Skippable News.

- **Triple P Network:** The Inyo County Triple P Network was scheduled to meet on January 9<sup>th</sup>. The Next meeting will be held on March 12<sup>th</sup>, 2024.
- Classes: Rebecca had 14 individuals complete the Parenting Fair inside the Inyo County Jail in December and were able to gift their children and families with recorded read aloud books and cards. On January 11<sup>th</sup>, Rebecca started a 12 week course in the Jail, Inside out Dad and Understanding Dad for Moms. Rebecca is currently offering a 4-week Primary Care course for parents of children 2-10 years old focusing individually on specific problems such as toilet



training, tantrums, etc. We will be investing in the 3<sup>rd</sup> Edition of Inside out Dad and working to delivery 24:7 Dad to the community.

- Home Visiting:

- <u>CHVP:</u> The California Home Visiting Program (CHVP) Evidence Based Home Visiting (EBHV) is working towards Parents as Teachers Affiliation and recruiting families to participate in the program. The Home Visiting Program will be hosting a <u>Free Play Group</u> for all parents with children prenatally to 5 years old on January 27<sup>th</sup>, 2024 from 11 AM to 1 PM.
- First 5 California Home Visiting Coordination: Staff have participated in Regional Home Visiting Coordination (HVC) meetings. Staff will be meeting with the local Bishop Tribe Language department to offer an opportunity for local Tribal Language holders to translate and/or publish books in their tribal languages. Regional staff have also developed an on-call schedule for Mono County Home Visitors and Inyo County Home Visitors to rotate calling in to NIH to inform and recruit new families.

#### <u>Literacy:</u>

- Reach Out and Read: Staff is maintaining the program, providing books as needed by the local clinics.
- <u>Imagination Library:</u> Registrations have increased to 379 children! We have had 222 children graduate turn 5 and graduate the program. During the winter months, Rebecca and Micaela hosted a series of Story times and each of the preschools in the County to promote DPIL.
- **Developmental Screenings:** Staff will be offering training to Southern Inyo Pediatrics this spring to train new staff.
- Quality Counts Inyo/IMPACT: The Quality Counts team is launched the new year and signed up providers. The team has been attending monthly HUB meetings. The Inyo QCC team will be meeting at the end of January to check in report back on mid-year check in's with providers.
- First 5 California: The First 5 California Summit will be March 25-27. Any Commissioners who
  are interested in attending are Welcome to attend. Staff will be in attendance to the summit.
