### 1. CALL TO ORDER AND INTRODUCTIONS

Anna Scott called the meeting to order at 2:30 PM. All attendees introduced themselves.

### **5. STAFF REPORTS (INFORMATIONAL ITEM)**

- 1) Behavioral Health Updates – Anna Scott
  - a) GHC (Generations Health Care) of Upland and GHC of Anberry contracts to be presented to Board of Supervisors (BOS) on 2/20/2024. The contract is for placement and treatment of individuals with severe mental illness.
- 2) Family Strengthening Team Updates – Jody Veenker
  - a) Currently working with 4 families
  - b) Received 5 referrals over the past 3 months/ 3 are in the orientation process.
  - c) Will do presentations to the preschool and early childhood providers of Northern Inyo.
  - d) Attending the February Student Attendance Review Board Meeting to outreach to 6 families with school attendance concerns.
  - e) Plan to train in Positive Parenting Program certifications in March to enable us to train parents to support their children in overcoming anxiety in workshops across Inyo County.
- 3) SUD Updates – Cathy Rigney & Gina Ellis
  - a) Staff turnover, exploring new ideas. Newest counselor is bilingual which facilitates services to underserved population in SUD (Bishop and Lone Pine (LP) locations) and with Inmates of Inyo County Jail. Has extensive knowledge gained in her work in LA County, including in detention facilities and prisons.
  - b) Procedures are being streamlined.
  - c) The difference between Substance Use Disorder (SUD) and Drinking under the influence (DUI) programs was explained.
- 4) Wellness Center Updates – Vanessa Ruggio
  - a) LP visits: 75, BH visits: 337, Bishop Groups
  - b) Washer & Dryer purchased for LP location.
  - c) New Wellness Center sign is in process.
  - d) New case manager will begin soon. The new employee will help to facilitate services in LP days to 3 days per week and offer groups.
  - e) Wellness Center Staff is being presented with “Most Improved Safety Award” by the Inyo County Risk Manager at the Board of Supervisors meeting on March 5, 2024.
- 5) Progress House Updates – Gina McKinzey on behalf of Kelly Nugent
  - a) Rooms are available for new residents and/or short-term respites.
  - b) Kitchen remodel is in progress. Larger size will facilitate working with clients in the kitchen.
  - c) Residents enjoy attending Art & Mindful Wellness Groups at Wellness Center.
  - d) State licensing was just renewed. Facility is licensed for ages 18 to 59.

## **6. AGENDA ITEM REQUEST FOR UPCOMING MEETINGS**

Ms. Martin asked when Mental Health Services Act (MHSA) Plan is due. Anna Scott explained that ICBH will be into a new 3 year plan. This will be brought before BHAB prior to July 1<sup>st</sup>.
