

EASTERN SIERRA COUNCIL OF GOVERNMENTS (ESCOG) BOARD OF DIRECTORS

PURPOSE: As established in the JPA, to provide a forum for discussion and study of regional problems of mutual interest to the member governmental entities.

ESTABLISHED: Replaces the Eastern Sierra Committee, and established by Board Order on February 28, 1995, and JPA dated April, 1995. The representative to this body also governs the **Eastern Sierra Transit Authority** which was formed under a separate MOU in July 1, 2007. Members of ESTA may not also serve on the Local Transportation Commission. A Joint Powers Agreement was approved by Inyo County on November 12, 2019.

COMPOSITION: Two elected members (and two alternates) of each legislative body are regular members, and associate members as described in the JPA, and Board Order dated May 2, 1995.

TERM: As stated in JPA (Inyo County Board appoints annually)
