## **CHILDREN AND FAMILIES FIRST COMMISSION (First 5)**

PURPOSE: Prop 10 passed in 1998 - recognizing the need to create and implement a

comprehensive, collaborative, and integrated system of information and services to promote, support and optimize early childhood development from prenatal stage to five (5) years of age. Further there is a need to ensure that early childhood development programs and services are universally and continuously available for

children until the beginning of kindergarten.

ESTABLISHED: Ordinance 1014, adopted April 20, 1999. Amended by Ordinance 1030, 9-12-00.

Amended again by Ordinance 1034, 12-5-00, by Ordinance 1054, 9-3-02, and

Ordinance 1245, 09-10-19.

COMPOSITION: Eight members: one (1) member of the Board of Supervisors, the Health and Human

Services Director or his/her designee, one (1) designee of the HHS Director from persons listed at Health & Safety Code Section 130140 (a)(1)(A)(i), and four (4) members who represent any of the following categories: (a) recipients of project services included in the County Strategic Plan; (b) educators specializing in early childhood development; (c) representatives of local child care resource or referral agency, or a local child care coordinating group (d) representatives of a local organization for prevention or early intervention for families at risk (e) representatives of community-based organizations that have the goal of promoting nurturing and early childhood development (f) representatives of local school districts and (g) representatives of a local medical, pediatric, or obstetric associations or societies; and

one alternate.

TERM: Three years and until the appointment of his/her successor
